With the assistance of a case manager, families develop goals to increase their ability to deal with life's challenges. SSHA's objective is to provide the means necessary to ensure that every family that enters our housing program will transition into permanent affordable housing with the skills necessary to create a stable living environment for their family. During 2020, we were able to assist over 25 families through our transitional housing association.
