During 2021, SSHA served 124 individuals with housing and support services. 83% of those who exited the program moved into stable permanent housing. In addition, SSHA was contracted by King County to provide rental assistance to households in the county facing eviction. We distributed over \$7 million in rental assistance to 575 households during 2021.

In 2001, St. Stephen Housing Association (SSHA) received a \$446,180 no-interest loan from the State of Washington Department of Community, Trade & Economic Development that is forgivable on 2/28/2051. This loan was not reported on SSHA's internal financial statements or tax returns prior to 2021.

SSHA received a second no-interest forgivable loan from the State of Washington Department of Community, Trade & Economic Development in 2019 for \$495,959. The 2019 loan, which was also not reported on SSHA's internal financial statements or tax returns prior to 2021, is forgivable on 6/27/2034.

A recommendation of a professional audit that was conducted of SSHA's financial statements during 2021 was that these forgivable loans be reported on SSHA's balance sheet. Accordingly, the \$942,139 (\$446,180 plus \$495,959) of loans were listed as a long-term liability with an off-setting entry to fund balances.
