During 2022, SSHA served 161 individuals (39 households) with housing and support services. 18 of 19 exiting households exited the program to permanent housing (95%). In addition, in partnership with King County and United Way, SSHA provided rental assistance to households in the county facing eviction. We distributed over \$5 million in rental assistance to 536 households in 2022.
